## How to gain online access to your ECP?



Simply go to the <u>Registration</u> website and select the option to confirm your identity online through mojeID service. The system will guide you through the steps to verify your data up to the activation of your online access.

## Why is it worth having online access to your ECP?

You will be able to:

- check the amount of your savings in the ECP account at any time and from any place;
- submit certain orders and instructions;
- specify persons who are entitled to inherit your savings;
- update your personal data;
- generate annual proof of payments made to the ECP;
- view the details of the ECP contract;
- open an IKE (Individual Pension Account) and IKZE (Individual Pension Security Account) with no handling fees;
- purchase participation units in selected sub-funds.

1) mojeID service can be used while creating an online account by any ECP participant whose bank is available for the purposes of this service (the bank's logo will be visible on the homepage);

2) If your bank is not available for the purpose of the service, please contact your employer who will request online access on your behalf (after completing and signing relevant documents).
